NOTIFICATION OF CLAIMS Against Warranty

This warranty does not cover dissatisfaction, problems or damage due to installation or maintenance other than as recommended by Julie industries. All claims under this warranty must be submitted, in writing, within five (5) days of discovery of any defect to:

STATIC PROTECTION

Static protection for Northland Series ESD Rubber Tile flooring is warranted to retain its conductive property within the specified resistance ranges for a period of 10 (ten) years from date of purchase, if the flooring is installed with the recommended Julie Industries conductive adhesive.

OBLIGATIONS OF WARRANTOR

Buyer's exclusive remedy against Julie Industries for claims arising here under for any and all losses and damages resulting from any cause shall be receipt of, at Julie Industries' option, either replacement of the defective merchandise, or a refund of the sale price of the defective merchandise. In no event shall Julie Industries be liable for incidental or consequential damages, even if some other provision of this LIMITED WARRANTY is unenforceable. Buyer Waives all other claims and remedies of any nature. Julie Industries StaticSmart Northland Series ESD Rubber Tile flooring is not designed for used in or near commercial kitchens or for outdoor use.
